

## **End User License Agreement**

**This End User License Agreement** (this "Agreement") is a legal agreement between you and ImageState Royalty Free Inc. ("ImageState"). Please read this Agreement carefully before purchasing and using any photographic image ("Image") from this CD ROM (the "CD"). By using an Image in any manner, you agree to be bound by the terms and conditions of this Agreement. If you do not wish to accept this agreement and you have not used any Image, promptly return the CD ROM with original package and materials for a full refund.

**Copyright/Conditions.** The CD and the Images are proprietary and copyrighted and all rights thereof are owned by ImageState and its suppliers. Your right to use an Image is subject to the restrictions set forth herein, and is conditioned upon (a) payment of the purchase price for the CD prior to your use of an Image and (b) compliance with the terms of this Agreement. You may not use the Images or the CD in any manner that is not permitted in this Agreement. All rights not specifically granted to you by this Agreement are reserved by ImageState.

**License Grant.** Subject to the restrictions set forth in this Agreement, ImageState hereby grants to you a non-exclusive, non-transferable right to use and reproduce Images from the CD only as follows: (a) on and in printed or other tangible materials, such as greeting cards, posters, phone or credit cards, advertising materials, packaging, catalogs, magazines or other periodicals, CD covers, and other similar materials; and (b) on and in digital or electronic media or materials, such as screensavers, websites, multimedia software, film and video and other similar media or materials; provided, however, that with respect to digital and electronic use, no Image may be used at a resolution greater than 480 by 640 pixels at 72 dpi.

**Restrictions.** You are not permitted to copy or distribute copies of the CD or the Images to others, and you may not share the CD or the Images with others except as follows: no more than ten (10) specific individuals (including you) who are employed by the same employer may have access to the CD and the Images. (If you wish to have more than ten (10) users, please contact ImageState.) You may not place the CD or an Image on a computer or other storage device which is accessible by more than one user at a time via a network connection or otherwise. Anything you produce using an Image must be for your own use, or for the use of your direct employer, client, or customer, who must be the end-user of your work. You may not use any Image in electronic templates or applications (whether web-based or not) for the purpose of creating, or allowing to be created, duplicates of an electronic or printed or other tangible product (such as electronic greeting cards, presentation templates, website designs, business cards, etc.). You may not sell, rent, loan, give, sublicense, or otherwise transfer to anyone either the CD or an Image, or the right to use the CD or any Image (except insofar as an Image has been incorporated by you into one of the permitted uses above), and nothing you produce shall grant or purport to grant to any third party a right to use or duplicate any Image. You agree to make commercially reasonable efforts to prevent third parties from duplicating or distributing the Images. If an Image depicts any person and is used in any

manner that implies endorsement, use of, or a connection to a product or service, you shall include in such use a written statement that the person is a model and is used for illustrative purposes only. This Agreement expressly prohibits pornographic, defamatory, negative, or otherwise unlawful use of the Image. You may not reverse engineer, decompile, or disassemble the CD, except and only to the extent that such activity is expressly permitted (notwithstanding this restriction) under applicable law.

**Breach of Agreement.** You agree to indemnify and hold ImageState harmless from and against any damages or liability of any kind arising from any use of an Image in breach of the terms and conditions of this Agreement.

**Warranties.** If this CD is defective, you may return it, together with original package and materials, for replacement or a full refund of your purchase price (at ImageState's discretion) within thirty (30) days of the date of purchase.

THE FOREGOING WARRANTY IS IN LIEU OF, AND IMAGESTATE HEREBY DISCLAIMS, ALL OTHER WARRANTIES, EXPRESS, IMPLIED OR ARISING BY LAW, WITH REGARD TO THE CD AND THE IMAGES, INCLUDING WITHOUT LIMITATION ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NONINFRINGEMENT, TO THE MAXIMUM EXTENT PERMITTED BY LAW.

**Disclaimer.** Any use of the CD and the Image is at your own risk. ImageState and its directors, officers, employees, partners, licensors, suppliers, or agents shall not be liable for any special, indirect, consequential, punitive, or incidental damages (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of, or the inability to use, the CD or any Image, even if ImageState has been advised of the possibility of such damages.
