

CORBIS ROYALTY-FREE END-USER LICENSE AGREEMENT

The following is a legal agreement between you and Corbis Corporation (“Corbis”). Please read this Agreement carefully before purchasing and using any Corbis royalty-free image (“Image”) from this CD ROM (the “CD”) or Website. By using an Image or otherwise exercising the rights granted under this agreement, you agree to be bound by this Agreement. If you do not wish to accept the terms of this agreement and you have not used any Image or otherwise exercising the rights granted under this agreement, you may return the CD ROM to Corbis for a refund of the purchase price.

1. The Images, CD and Website are copyrighted. All rights are owned by Corbis and its suppliers. All rights not specifically granted to you by this Agreement are reserved by Corbis. Your right to use an Image is subject to the restrictions set forth in this Agreement, and is conditioned upon your payment of the purchase price for the Image or CD prior to your use of an Image and your compliance with the terms of this End-User License Agreement.

2. By this Agreement, Corbis grants to you a non-exclusive, non-transferable right to use and reproduce purchased Images from the CD or the Corbis Website in the following, and only the following, ways:

(a) Print Uses: any printed, tangible materials including greeting cards, T-shirts, postcards, posters, phone cards, credit cards, templates, CD covers, cassette covers, board games, calendars, magazines, newspapers,; advertising, editorials, catalogs, brochures, reports, disposable packaging, book covers, and educational text books; Notwithstanding the rights granted above, the Images cannot be used for “retail photo products” (including, but not limited to, retail greeting cards, retail calendars, retail postcards, retail posters, retail t-shirts, and retail mugs, that are offered for sale.)

(b) Other Than Print Uses: any electronic or digital materials including screensavers, electronic greeting cards, Websites, broadcast video, multimedia including film and video, and CD ROMs, **provided** that no Image is at a resolution greater than 480 by 640 pixels and each Image is incorporated into a design in such a fashion that it is clearly not intended to be downloaded or copied.

3. “Non-transferable,” as used in Paragraph 2, means that the work you produce using an Image must be for your own use, or for the use of your direct employer, client, or customer, who must be the end-user of your work. You may not sell, rent, loan, give, sublicense, or otherwise transfer to anyone either the CD or an Image, or the right to use the CD or an Image (except insofar as an Image has been incorporated by you into one of the permitted uses enumerated in Paragraph 2 of this Agreement), and nothing you produce shall grant or purport to grant to any third party a right to use or duplicate an Image. You agree to take all commercially reasonable steps to prevent third parties from duplicating or distributing the Images.

4. When a CD is purchased by a company, this license agreement authorizes up to five (5) individuals (total) to use the Images contained on the CD and exercise the rights described in this agreement. You may not place the CD or an Image on computer or other storage device, which is accessible by more than one user at a time via a network connection or otherwise.

If an Image depicts any person and is used in any manner that implies endorsement, use of, or a connection to a product or service, you shall include in such use a written statement that the person is a model and is used for illustrative purposes only.

6. You agree to indemnify and hold Corbis harmless against any damages or liability of any kind arising from any use of an Image other than the uses specifically permitted by this Agreement.

7. Neither Corbis nor any of its directors, officers, employees, partners, licensors, or agents shall be liable for any indirect, consequential punitive, or incidental damages arising out of the use of, or the inability to use, the CD or an Image, even if Corbis has been advised of the possibility of such damages. In no event shall Corbis' liability (whether in tort, contract, or otherwise) arising out of or relating to your use of the CD or Images or inability to use the CD or the Images exceed the fees paid by you for the CD.

8. Corbis warrants that for the period of 90 days, the CD will, when properly used, be capable of performing substantially in accordance with the associated documentation. As Corbis' only responsibility and liability under this warranty, and as **YOUR SOLE AND EXCLUSIVE REMEDY**, Corbis shall either (at its sole option) repair or replace the defective portion of the CD or refund the amounts paid for the CD upon the return of the CD and all accompanying materials to Corbis. **THE FOREGOING WARRANTY IS IN LIEU OF, AND CORBIS HEREBY DISCLAIMS, ALL OTHER WARRANTIES, EXPRESS, IMPLIED OR ARISING BY LAW, WITH REGARD TO THE CD AND THE IMAGES, INCLUDING WITHOUT LIMITATION ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.**

9. This Agreement shall be governed by the laws of the State of New York, except its conflict of laws rules. Venue for any action respecting this Agreement, an Image, or use or attempted use of the CD, shall be in the state and federal courts sitting in New York County, New York and you hereby consent to the jurisdiction of such courts.
